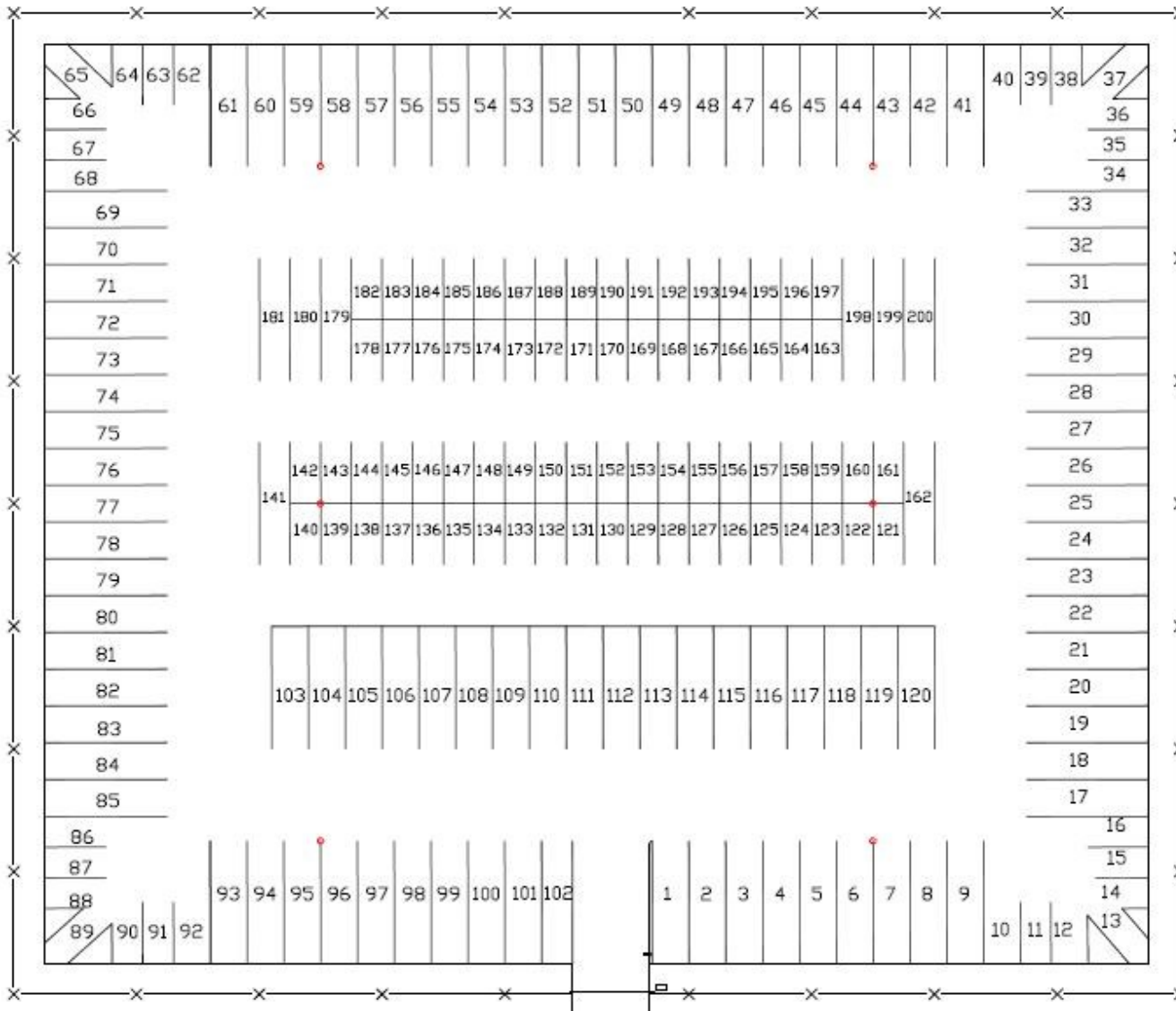


Your Assigned Spot

Registration

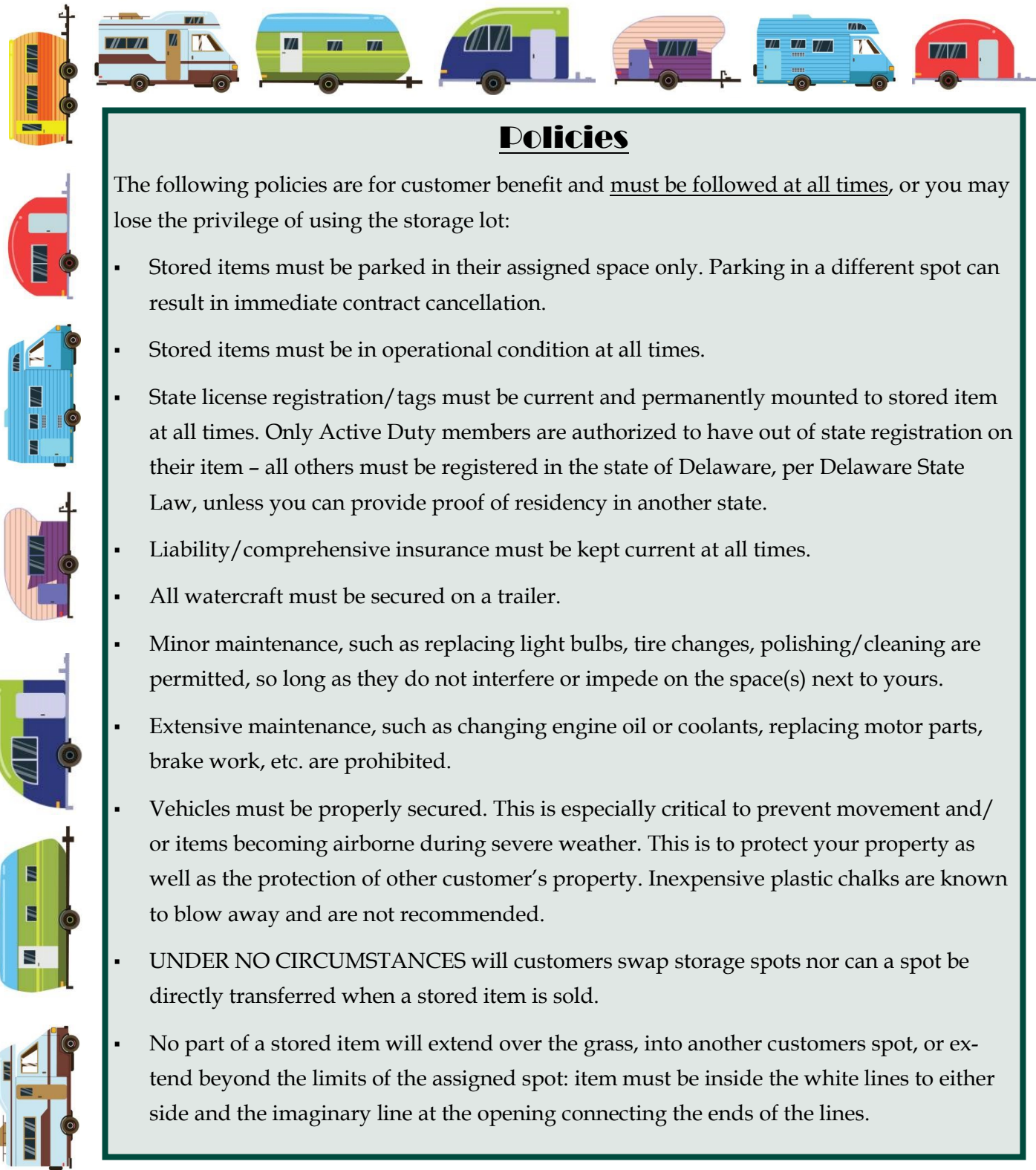
Register your RV/Camper/Trailer/Boat/

You will need your state issued vehicle
registration card, proof of insurance and
DoD ID card. ALL ITEMS STORED MUST
BE PROPERLY REGISTERED AND
DISPLAY CURRENT LICENSE TAGS AT
ALL TIMES.

Fees

Participation on the orbital billing system
is required – this system stores credit or
debit card information and automatically
charges your card for your monthly
payment. The only exception is for short
term non-renewable contracts of 6 months
or less and must be paid in full up front.

Policies

The following policies are for customer benefit and must be followed at all times, or you may lose the privilege of using the storage lot:

- Stored items must be parked in their assigned space only. Parking in a different spot can result in immediate contract cancellation.
- Stored items must be in operational condition at all times.
- State license registration/tags must be current and permanently mounted to stored item at all times. Only Active Duty members are authorized to have out of state registration on their item – all others must be registered in the state of Delaware, per Delaware State Law, unless you can provide proof of residency in another state.
- Liability/comprehensive insurance must be kept current at all times.
- All watercraft must be secured on a trailer.
- Minor maintenance, such as replacing light bulbs, tire changes, polishing/cleaning are permitted, so long as they do not interfere or impede on the space(s) next to yours.
- Extensive maintenance, such as changing engine oil or coolants, replacing motor parts, brake work, etc. are prohibited.
- Vehicles must be properly secured. This is especially critical to prevent movement and/or items becoming airborne during severe weather. This is to protect your property as well as the protection of other customer's property. Inexpensive plastic chocks are known to blow away and are not recommended.
- UNDER NO CIRCUMSTANCES will customers swap storage spots nor can a spot be directly transferred when a stored item is sold.
- No part of a stored item will extend over the grass, into another customers spot, or extend beyond the limits of the assigned spot: item must be inside the white lines to either side and the imaginary line at the opening connecting the ends of the lines.
